Congratulations! The AIHA Laboratory Accreditation Programs (AIHA-LAP), LLC's Analytical Accreditation Board (AAB) has approved Aerobiology Laboratory Associates, Inc. as an accredited Environmental Microbiology laboratory.

Please see AIHA-LAP Policy 3.5.10 on surveillance visits.

The accreditation certificate is the property of AIHA-LAP, LLC and must be returned to us should your laboratory withdraw or be removed from the EMLAP.
